**12.3 Bioaccumulative potential**

An estimated BCF of 3.2 was calculated for dihydrotachysterol(SRC), using an estimated log Kow of 10(1) and a regression-derived equation(2). According to a classification scheme(3), this BCF suggests the potential for bioconcentration in aquatic organisms is low(SRC).

**12.4 Mobility in soil**

Using a structure estimation method based on molecular connectivity indices(1), the Koc of dihydrotachysterol can be estimated to be  $2.5 \times 10^6$ (SRC). According to a classification scheme(2), this estimated Koc value suggests that dihydrotachysterol is expected to be immobile in soil.

The material can be disposed of by removal to a licensed chemical destruction plant or by controlled incineration with flue gas scrubbing. Do not contaminate water, foodstuffs, feed or seed by storage or disposal. Do not discharge to sewer systems.

**Contaminated packaging**

Containers can be triply rinsed (or equivalent) and offered for recycling or reconditioning. Alternatively, the packaging can be punctured to make it unusable for other purposes and then be disposed of in a sanitary landfill. Controlled incineration with flue gas scrubbing is possible for combustible packaging materials.
